PAYMENT/ CHANGE IN REGISTRATION /REFUND POLICY

- There is a **\$25 non-refundable deposit** included in the camp registration fee for each session registered for. All balances are due **MAY 29, 2026.**
- **Refund** requests must be made in writing to the Parks & Recreation Department and must be submitted **by May 29th.** Please email your request to recreation@northamptonma.gov.
- *Our refund policy is strictly enforced to allow completion of camp preparations ranging from staff hiring, camper groupings, field trip planning and entry tickets, to supply purchasing.*
- **There will be NO REFUNDS after MAY 29, 2026.**
- **In addition to the non-refundable \$25 fee, there is a \$10 processing fee for all refunds.**
- Credit card refunds will be applied to your credit card. If you paid with cash or check you will receive a refund check from the City of Northampton, please allow 2-4 weeks for processing.

The Northampton Parks & Recreation department is partnering up with CampDoc, an electronic health record system used by camps. You will receive an invitation to create a profile. *Each camper will have their own profile which must be 100% complete before your child is allowed to attend camp.* If you do not receive this invitation, please email recreation@northamptonma.gov or call us at (413) 587-1040.

IMPORTANT HEALTH INFORMATION

PHYSICAL AND IMMUNIZATION FORMS. You must upload your child's current **Physical and Immunization forms** (within the last 15 months) into CampDoc. The MA State Board of health requires your child have this information on file with us before they are allowed to attend camp. They **MUST** be submitted by the deadline of **MAY 29** in order for the MA Board of Health to complete their records review.

EPI-PENS/DIABETES

For Children who have allergies that require an Epi Pen and/or those with Diabetes, **Northampton Parks & Recreation requires that we have Emergency Action Plans and Medical Authorization Orders from your child's Physician.** These forms will be submitted to your Campers CampDoc profile to be considered complete.

MEDICATION

We strongly encourage all medications be administered at home. If that is not possible, **Northampton Parks & Recreation requires that we have Emergency Action Plans and Medical Authorization Orders from your child's Physician.** These forms need to be completed and submitted to your Campers **CampDoc by FRIDAY MAY 29**.
